## MINUTES FOR REGULAR COUNCIL

MINUTES JULY 8, 2025

- A. The mayor called meeting to order at 6:32 p.m.
  - B. Roll Call: Naomi Machuca, Rick Martinez, Mayor Begay, Gordon Hoyt and Pamela Hoyt Guests: Berta and Dearheart Begay and Wayne and Mira Monton
  - C. Prayer: Wayne Monton

- 1. Approved minutes for 6/10 and 6/27/25 first motion by Naomi and the second motion by Rick AIF
  - 2. Approved financial report for 06/25 first motion made by Naomi with the second motion by Pamela AIF Gordon Hoyt voted No
  - 3. The mayor gave a brief report on sewer and water department with not a lot of change for the month
  - 4. The mayor presented the contract between the city and the county to further the well project some discussion was had with Rick asking for a small change in verbiage.
  - 5. Filling the empty council seat left by Mr. Chapman we had given notice and asked candidates to submit paperwork to verify eligibility. Two people were in attendance with only one actually submitting appropriate paperwork to be eligible. Mr. Wayne Monton argued on his behalf that he was able to hold the seat even though he

could not provide the accurate documentation in the allotted time. Naomi stated she had called the courthouse 3 different times that day to try and verify him. The Teams website was down but a paper record could not be located either. Ms. Berta Begay being the other candidate did meet the requirements and met the deadline. During discussion Mr. Hoyt became very angry and ultimately said he could not continue to work with the Mayor and walked out stating he was resigning at 7:45pm Mayor asked for a vote and Naomi made motion to accept Berta Begay for the one year unexpired term left by Leroy Chapman with it being seconded by Pamela AIF motion carried

Updates were given by Mayor Begay on the Interlocal agreement with Reeves County which is in the county's hands for approval. The amendment for transferring funds to purchase water was made and money transferred on July 2, 2025. The city has yet to hear or receive any information on a B operator and the AG agreement still needs to be decided on for future projects concerning grants with the City.
