## MINUTES FOR REGULAR CITY COUNCIL MEETING TUESDAY MAY 13, 2025

Meeting called to order by new Mayor at 6:34 p.m. Mayor gave a small speech as her first meeting as current mayor and introduced herself.

ROLL CALL: Mayor Begay, Naomi Machuca, Rick Martinez, and Pamela Hoyt absent was council member Leroy Chapman

PRAYER: Dearheart Begay led prayer

As requested by city attorney, on department reports we went directly to to executive session so that she would be available by phone as she was attending another meeting at the same time. Ex. Session 6:39 p.m. Back into open session at 7:18 at that time Mayor Begay asked for motion on topic discussed in closed session. Naomi made first motion to accept former water/wastewater operator Brandie Baker's resignation effective on May 8, 2025. Rick Martinez made second motion all in favor motion carried.

FINANCIAL REPORT: after short discussion the financial report for April/2025 was voted on, Naomi made first motion, Rick made second motion all in favor motion carried.

APRIL MINUTES 2025: Naomi made first motion to accept last months minutes, seconded by Rick motion carried.

5. Gordon Hoyt had requested to be appointed to one-year open seat as he did not run for the Mayor position this year. Mr Hoyt was sworn in for one year.

UPDATES: Mayor Begay will also discuss the used asphalt from the interstate construction she will get in touch with TxDot on this.

Mayor Begay attended a meeting in Balmorhea on May 12, 2025, this was in conjunction with Balmorhea, ground water district and the swimming pool.
